Ministry of the Environment held an "International Conference on Climate Change and Coral Reef Conservation" on 29-30 June, 2013. (http://www.env.go.jp/en/nature/npr/iccccrc2013/)

Ministry of the Environment enlarged a "Marine Park Zone" of Setonaikai National Park that covers seaweed beds and coral communities, including the biggest community of *Alveopora japonica* in Japan.

Ministry of the Environment is in a process of establishing a National Park on Kerama Islands in Okinawa Prefecture, which are currently designated as a Quasi-National Park and a Ramsar Site (no. 1546: Kerama-shoto Coral Reefs).

### 3. Contribution to the ICRI GM

#### a. Community-based monitoring

Are you engaged in, or support community-based monitoring in your marine areas? If so, think about what works and what doesn't with it to be prepared for workshop discussions on this topic. The discussions will revolve around:

• The benefit of community-based monitoring for management and reporting

• Way forward and how countries could support each other through a network of persons involved in monitoring and an online database.

The Ministry of the Environment implements coral monitoring under the "Monitoring Sites 1000" program, but it is not community-based. The fishery resources are monitored by local governments based on the data from local fisheries cooperatives.

Communities are usually not interested in monitoring what is not relevant to their livelihoods or what they cannot manage. If they see relevance in coral reefs, they may monitor the status of corals voluntarily, which can be low-cost and more frequent compared to the government-led monitoring.

On the other hand, it is up to the communities to submit the data, and the communities are not accountable for the results of monitoring if it were conducted voluntarily.

Transparency and standardization of monitoring methods would be desired from the viewpoint of governments and scientists, and this would require clear benefits for the communities (i.e., feedback from governments and scientists in the form of data analysis and prediction, advice on management, etc.).

#### b. Co-management
